

## Franco Moscetti

President of the Advisorv Board Axelcomm

He was born in Tarquinia (VT) in 1951 and began his career in the Air Liquide Group in 1973. After various experiences, in 1989 he was appointed General Manager of Vitalaire Italia, a company specialized in home care services and based in Rome. In 1992, he moved to Milan and in 1995 he was appointed General Manager and Managing Director of Air Liquide Sanità, a sub-holding company that brings together all the group's healthcare activities in Italy. In 1999 he was also appointed Managing Director of the parent company Air Liquide Italia. While maintaining his Italian positions, in 2001 he moved to Paris where he took over the International Hospital Division, also becoming the Président-Directeur Général of Air Liquide Santé France, which is the most important subsidiary of the AL Group in the sector. He serves on the boards of the Group's most important subsidiaries internationally. He was awarded the Oscar di Bilancio – for the 'unlisted companies' category – in December 2000 by the then Finance Minister Vincenzo Visco. In 2002, he was also awarded the "Stella al merito del Lavoro" (long service award) and the title of "Maestro del lavoro" (Labour Master) by the then President of Italy, Azeglio Ciampi. In June 2003, he received the "Ambrogino" (Golden St. Ambrose medal) from the Mayor of Milan Gabriele Albertini. On June 2, 2012 he was appointed "Cavaliere del Lavoro" by the President of Italy Giorgio Napolitano and on December 5, 2013, by decree of the President of the French Republic, he was appointed "Officier de l'Ordre National du Mérite". From December 2004 until October 2015, he was General Manager and Chief Executive Officer of the Amplifon Group, the world's leading company in personal hearing solutions, and from November 2016 until June 2018 he was Chief Executive Officer of the 24 Ore Group. He is currently the Sole Director of Axel Glocal Business S.r.l., a company he founded, and sits on the boards of directors of Diasorin S.p.A., Zignago Vetro S.p.A., ASTM Group (of which he is Deputy Chairman), Fideuram Investimenti SGR (of which he is Deputy Chairman), OVS Group (of which he is Chairman), Pellegrini Group S.p.A. and Clessidra Capital Credit SGR. He received a high school degree in Industrial Sciences from the Akademie Herisau AR (CH) and he was also Senior Advisor to UBI Banca and Chairman of the Advisory Board of the SPAC "Life Care Capital".
